## LIMITED WARRANTY ON DB22 HEADPHONES

Thank you for selecting Vic Firth Co. DB22 headphones. Vic Firth Co. headphones are designed to provide a high level of performance for sound reduction levels by 25 decibels.

### Coverage:

As of July 1st, 2013, Vic Firth Co. warrants the DB22 headphones against defects in material or workmanship under normal use and service for a period of 1 year from the date of purchase by or for the original owner. If a product fails to conform to this limited warranty, Vic Firth Co. will, at its option, refund the purchase price of the product, or repair or replace the non-functioning or defective product.

This warranty is extended only to the original end-use purchaser or the person receiving the product as a gift, and shall not be extended to any other person or transferee. This warranty does not apply to any initial user or purchaser who allows this product to be used by multiple persons. This warranty is extended for non-commercial use only. This warranty excludes damages resulting from negligence, misuse, abuse, accident, modifications, extremes in temperature or humidity, or other causes that are not defects in materials and workmanship. This warranty does not cover normal wear and tear, scratches, loss or theft. Vic Firth Co. reserves the right to replace any discontinued product with one of equal value.

### In Order to Obtain Warranty Service:

- 1) If you believe that your Vic Firth product has a defect covered by our warranty, contact Vic Firth Co. for a Return Authorization Number (RA#) by calling 617-364-6869 or email [Warranty@vicfirth.com](mailto:Warranty@vicfirth.com).
- 2) Place your RA # on the outside of the package.
- 3) Place your damaged product in the package.
- 4) Include your name, return address and RA # on a note inside of the package with a copy of the original sales receipt.
